

Lanier Auxiliary Racing Committee (LARC)
Notice of Race and Sailing Instructions
Winter (UYC), Moonlight (BFSC), & Fall (LLSC) Series 2026

1. Rules

The races will be governed by the "rules" as defined in the Racing Rules of Sailing 2025-2028 (RRS). The Series is designated Category A and is hosted by Barefoot Sailing Club, Lake Lanier Sailing Club and University Yacht Club. The series are organized by the Lanier Auxiliary Racing Committee (LARC).

2. Entries

- A. Eligible skippers are entered by being a member of good standing of any hosting authority; the Barefoot Sailing Club, Lake Lanier Sailing Club, or the University Yacht Club. Skippers should complete a registration form for each series at each of the skipper's meetings. For this series boats must be as follows: a self-righting monohull 19.5 feet LOA or above, or a multihull that has sleeping accommodations and holds a current Lake Lanier Performance Handicap Racing Fleet (LLPHRF) Handicap Certificate.
- B. Eligible skippers are entered by being a registered member of any organizing authority, the Barefoot Sailing Club, Lake Lanier Sailing Club (Keelboat Fleet), or the University Yacht Club. Skippers should complete a registration form at each of the skipper's meetings.
- C. Skippers may enter any self-righting monohull 19.5 feet LOA or above, that hold a current Lake Lanier Performance Handicap Rating (LLPHR) or a multihull that hold a current Lake Lanier Performance Handicap Racing (LLPHRF) Handicap Certificate. (i.e. no dinghies).
- D. Either the registered skipper, or the designated alternate skipper as submitted in writing to the organizing authority in advance of the race for which the alternate is designated, must be on board for each race of the series. The registered and/or designated alternate skipper may change boats for different series, but shall not change within a series. This means that a single hull must be used within a series. A registered and alternate skipper shall not be assigned to more than one boat during a series. The registered and/or alternate skipper may crew on another yacht, but shall not skipper or helm the other yacht.
- E. All entrants may carry a current copy of the event permit from the Georgia Department of Natural Resources and the U.S. Army Corps of Engineers. This is available from the Race Committee or at the skipper's meeting if one was not received when registering with one of the organizing authorities.
- F. A participant in this event shall hold all organizing bodies, its officers, representatives, agents, Race Committee members, and Co-Sponsors harmless for any bodily injury or physical damage that may occur during these events, to include after race and other social gatherings. By their participation, persons involved with these events acknowledge and agree with this provision.

3. Notices to Competitors

Notices to competitors shall be posted on the LARC web site official notice board at LLSCKeelboat.com/LARC.html and will be sent by email to all registrants from previous year. Copies of the sailing instructions will also be available at the Skipper's Meetings. All boats must have a valid PHRF rating certificate. Go to sail-lanier.com/PHRF to apply for a certificate and/or contact your club's representative: Kent Rogers UYC, Chris Webster BFSC or Jonathan Stewart LLSC.

4. Changes in Sailing Instructions

Any change to the sailing instructions, including any change to the schedule of races, shall be posted on the official notice boards of the organizing authorities and at the LLSCKeelboat.com/LARC.html website at least two days prior to the date on which the change will take effect and by email to all registered skippers.

6. Classes and Flags:

- A. Fleets will be determined at the skipper's meeting of Race 1 of each series. The fleets **may be**:

- a) Fleet 1- Low Asymmetrical may consist of all planing hull sport boats.
- b) Fleet 2 and 3- Low/High PHRF may include non-spin boats with a 15 seconds per mile adjustment.
- c) Fleet 4 may include Non-Spinnaker boats with the following qualifications: Displacement hull with fixed keel, No spinnaker, One headsail at a time (except for cutter designed sailboats), No staysails, Operating inboard/outboard engine, Functioning head and galley, and Interior cushions.
- B. Any boats which don't specifically fall into one category will have their placement decided by the flag officers of LARC.
- C. The LLPHRF rating assigned to each fleet may be re-assigned at the skipper's meeting of the first race in each series.
- D. Class flags may be designated by Number Pennants

7. Racing Area

The racing area will be any area of Lake Lanier south of Brown's Bridge (map of commonly used marks are attached).

8. Time Limit

Boats failing to finish within 5 hours of the first start will be scored DNF (number of boats registered for that race +1). This changes RRS rule 35 and A4.1.

9. Withdrawal

Boats withdrawing from a race shall notify the Race Committee (either club member who is running the race or Dana Stewart) by radio or phone, as soon as possible. This is very important because we want to keep this sport as safe as possible and it helps us to know what has happened to all registered boats.

10. Protest

- A. A protesting boat shall notify the Race Committee or the LARC administrator, Dana Stewart (stewartdana3363@gmail.com), of intent to file a protest immediately upon finishing the race. This changes RRS rule 61. The protestor must clearly identify the protested boat(s) to the Race Committee, but shall not interfere while the Race Committee records other finishes.
- B. Protest forms are available on the US Sailing web page at <http://www.ussailing.org>.
- C. Protests should be delivered or emailed to either Dana Stewart, within 2 hours of the protestor's finish OR the protest form may be delivered not later than **11:59 p.m of the day following the race in** which the protested incident occurred. Fax or e-mail is acceptable. This changes rule 61.3.
- D. Protests should be addressed to the **LARC administrator Dana Stewart**.
- E. Protestor shall indicate, on the protest form, the extenuating circumstances which prevented compliance with Item 13.7 above.
- F. Protest hearings are scheduled as soon as possible or immediately following the race in which the incident occurred.
 - a) All parties to protests will be notified of the scheduled protest not later than the day proceeding the day for which the protest is scheduled.
- G. Protest hearing dates and times may be changed only at the discretion of the appropriate organizing authority and/or the protest chairman
 - a) Skippers with conflicts may designate an alternate representative by contacting the appropriate organizing authority at least 24 hours in advance.

11. Scoring

- A. The time-on-distance method of PHRF handicapping will be used.
- B. The Low Point scoring system, RRS rule A4, will apply, with the exception that the suggested wording from RRS rule A4 will replace the second paragraph of RRS rule A4.2 as follows:
 - a) Boats not scored that came to the starting area will be scored points for the finishing place one more than the number of all boats that came to the starting area (DNF).
 - b) Boats that did not come to the starting area will be scored points for the finishing place one more than the number of boats entered in the series (DNC).

- C. For the Winter, Moonlight and Fall series, 4 races are scheduled each, of which 1 race shall be completed to constitute a series.
- D. If 3 or more races are scored for each series, a throw out will be given. This changes RRS rule A2.
- E. The Race Committee shall provide the race results to the official scorekeeper within 24 hours.

12. Trophies

- A. Trophies will be awarded for each series, Fall and Winter series will be awarded at the Wed. night Series 1 party on June 24 and the Moonlight series trophies will be given at Wed night Series 2 awards party on Sept. 16.
- B. At registration, the skipper of each boat shall declare the club under whose burgee they will be representing in that year's LARC series.
- C. Each skipper must be a member in good standing of one of the following clubs: Barefoot Sailing Club, Lake Lanier Sailing Club or University Yacht Club.
- D. The registered club affiliation cannot be changed throughout a LARC series.

13. Replacement of Crew

- A. Substitution of crew is allowed at any point in between races. Either the registered skipper or the designated alternate skipper must be on board for each race of the series.
- B. The registered and/or designated alternate skipper may change boats for different series, but shall not change within a series.
- C. A registered and alternate skipper may crew on another boat, but shall not skipper or helm the other boat.

14. Trash

Any boat seen by the Race Committee throwing trash into the lake may be given a 20 percent scoring penalty. Such penalty will not be grounds for redress.

15. Disclaimer of Liability

Competitors participate in these races entirely at their own risk. See RRS 4, Decision to Race. The organizing authorities will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the races. By their participation, any persons involved with these races acknowledge and agree with this provision

16. Winter series hosted by University Yacht Club

- A. Schedule of races:
 - Race #1 on Sat. Jan 3
 - Race #2 on Sun. Jan 25
 - Race #3 on Sat. Feb 14
 - Race #4 on Sun Mar 15
- B. Skipper's Meeting:
 - a) All races during the Winter series will be started using staggered (pursuit) starts..
 - b) Skipper's meetings are scheduled to be held, but are subject to change, at 11 a.m. prior to each race at will be held at UYC.
 - c) Attendance is required to get RC instructions, start times and course (staggered start), and starting area.
 - d) Races are scheduled to begin at 1 p.m. Races are scheduled to start in the vicinity of "X" mark (Island 18), but **may be moved elsewhere at the discretion of the Race Committee**.
 - e) To register, send an email to either stewartdana3363@me.com or text me at 404/849-1809 by Friday of your intention to sail. You will need to send me the following information; 1) PHRF rating, 2) skipper's name, 3) sail #, 4) type of boat/name of boat, and 5) club affiliation
 - f) Each boat/skipper will need to report their finish time (time of day) within 24 hrs of start time to either stewartdanam@me.com or text me (404/849-1809) to be scored.

C. The Course

- a) Courses will be designated by permanent Corps of Engineers (COE) marks identified on the map or temporary marks consisting of tetrahedrons or balls.
 - 1) Islands 8, 10, 13, and 16 are boundary markers.
- b) Pursuit or staggered starts
 - 1) Course, distance and starting area will be posted at the skipper's meeting.
 - 2) Staggered start time for each boat using LLPHRF rating and distance will be calculated at the skipper's meeting.
- c) Courses will be designated by the mark's letter and the side of the boat to which the marks are to be left. Example "F-P, D-P, X-P-Finish." "P" (port rounding) will designate if marks are to be left to port. "S" (starboard rounding) will designate if marks are to be left to starboard.
- d) If temporary marks are used, the course designation will show the closest permanent mark followed by "T" and the direction the mark is to be rounded. (For example 16TP meaning round the temporary mark closest to Corps of Engineers mark 16 leaving it to port.)
- e) The Race Committee MAY provide separate courses for different fleets.
- f) At the discretion of the Race Committee, a part of the course specified may be a designated "gate" through which boats on that course shall sail.
 - 1) For this purpose, a gate will be defined as the space created where a line would be drawn between the race committee boat and a nearby mark.
 - 2) A direction through the gate, indicated on the course board, shall specify the required side on which to pass the mark, for example: a gate at X mark, moving from D through the gate to F, taking X to Starboard, shall be specified on the course board as "X-S Gate."
- h) If the gate is used as a rounding mark, boats may round either mark or the race committee boat. This changes RRS rule 28.

D. The Start

- a) Races shall be started using the staggered start system.
- b) Each boat shall have its own specific start time as determined by each boat's specific PHRF rating and the course length. Start times for each boat will be obtained at the skipper's meeting.

 - 1) **The Start Line may be between F mark and T mark.**

- f) All starts are based upon the honor system as a committee boat is usually unavailable to keep an eye on start times. It is the responsibility of each skipper to synchronize his or her own starting watch with that of the official starting clock posted on the official course board at the skipper's meeting.

E. The Finish.

- a). The Finish Line will be an imaginary line that extends no further than 20 yards and is perpendicular to the last mark. For a proper finish, you must end your race within 20 yards of the proper side of the finishing mark as indicated on the official course board.
 - 1) The Finish Line may be between F mark and the flagpole at LLSC
- b). SF- Short Finish As part of the published course, one mark will be determined to be the short finish mark. A time will be assigned to that mark if the lead boat DOES NOT reach the Short finish mark by the predetermined time. The race will be shortened at that point.
 - 1). NOTE: The rules for a proper finish still apply to a "Short Finish" course. (Example: 11P SF 4pm, If lead boat does not pass 11 to port by 4pm then the race is shortened at that mark for all boats)
- c). Each skipper is responsible for reporting (text) his/her finish time to LARC scorer (Dana 404/849-1809) within 24 hours of start time.
- d). MT- Motor Time As part of the published course, a Motor Time will be determined. If a boat does not finish the race by the predetermined time, the race is over for that skipper and the boat will receive a Did Not Finish (DNF) for the race. (Example: MT is 4pm, if you have not finished the race by 4pm then start your motor, because you are DNF)

17. Moonlight series hosted by Barefoot Sailing Club

A. Schedule of races:

Race #1 on Sat. May 3
Race #2 on Sat. May 30
Race #3 on Sat. July 25
Race #4 on Sat. Aug 29

B. Skipper's Meeting:

- a) All races during Moonlight series will be started using staggered (pursuit) starts..
- b) We will have the skipper's meeting at 6pm at "X" dock at Aqualand
- c) Attendance is recommended to get RC instructions, start times and course (staggered start), and starting area .
- d) To register, send an email to either stewartdana3363@me.com or text me at 404/849-1809 by Friday of your intention to sail.
- a. You will need to send me the following information; 1) PHRF rating, 2) skipper's name, 3) sail #, 4) type of boat/name of boat, and 5) club affiliation
- e) Each boat/skipper will need to report their finish time (time of day) within 24 hrs of start time to either stewartdanam@me.com or text me (404/849-1809) to be scored.
- f) The base start time is 8 pm, specific start time is given at skipper's meeting.
- g) Races are scheduled to start in the vicinity of "X" mark (Island 18), but may be moved elsewhere at the discretion of the Race Committee.

C. The Course

- a). Courses will be designated by permanent Corps of Engineers (COE) marks identified on the map or temporary marks consisting of tetrahedrons or balls.
 - 1). Islands 8, 10, 13, and 16 are boundary markers.
- b). Pursuit or staggered starts
 - 1). Course, distance and starting area will be posted at the skipper's meeting.
 - 2). Staggered start time for each boat using LLPHRF rating and distance will be calculated at the skipper's meeting.

 - d). MT- Motor Time As part of the published course, a Motor Time will be determined. If a boat does not finish the race by the predetermined time, the race is over for that skipper and the boat will receive a Did Not Finish (DNF) for the race. (Example: MT is 4pm, if you have not finished the race by 4pm then start your motor, because you are DNF)

18. Fall series hosted by Lake Lanier Sailing Club

- A. Schedule of races:

Race #1 on Sun. Aug. 16
Race #2 on Sun. Sept. 27
Race #3 on Sun. Nov 1
Race #4 on Sun. Nov 22
- B. Skipper's Meeting:
 - a) All races during Fall series may be started using a flat start or a pursuit start.
 - b) Skipper's meetings are scheduled to be held, but are subject to change, at 11 a.m. prior to each race at LLSC clubhouse.
 - c) Attendance is recommended to get RC instructions, start times and course, starting area and any after-race party location.
 - d) Races are scheduled to begin at 1 p.m. Races are scheduled to start in the vicinity of "X" mark (Island 18), but may be moved elsewhere at the discretion of the Race Committee.
 - e) LLSC will provide a breakfast at 10am at LLSC clubhouse before the skipper's meeting of the last race on Sat. Nov. 22.
- C. The Course
 - a). Courses will be designated by permanent Corps of Engineers (COE) marks identified on the map or temporary marks consisting of tetrahedrons or balls.
 - 1). Islands 8, 10, 13, and 16 are boundary markers.
 - b). Pursuit or staggered starts
